RESOLUTION NO. 113

"WHEREAS, this august Body finds the claims for payment of per diems, allowances and other expenses of Pat. Rosito Alcorido of Tagum, Davao del Norte, in order, considering that his travel to Ormoc City to appear before the Office of the City Fiscal as Government witness in a homicide case against Mateo Pepito et al is authorized as per Section 12 of Republic Act 5185, otherwise known as the Decentralization Act of 1967;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilor Kangleon;

"RESOLVED, to adopt:

ORDINANCE NO. 33

AN ORDINANCE APPROPRIATING ₱137.00 FOR TRAVEL AND TRANSPORTATION OF PAT. ROSITO ALCORDO OF TAGUM, DAVAO DEL NORTE

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of One Hundred Thirty-Seven Pesos (₱137.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the city treasury to be made available as supplemental appropriation for the travel and transportation of Pat. Rosito Alcorido of Tagum, Davao del Norte, to Ormoc City to appear before the Office of the City Fiscal as Government witness in a homicide case against Mateo Pepito et al.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
