ORDINANCE NO. 34

AN ORDINANCE REVERTING P500.00 FROM SALARY SAVINGS OF THE AUDITING DEPARTMENT TO APPROPRIATION FOR TRAVEL AND TRANSPORTATION OF SAME

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Five Hundred Pesos (P500.00), or so much thereof as may be necessary, is hereby reverted from salary savings of the Auditing Department to be made available for appropriation for its travel and transportation.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
