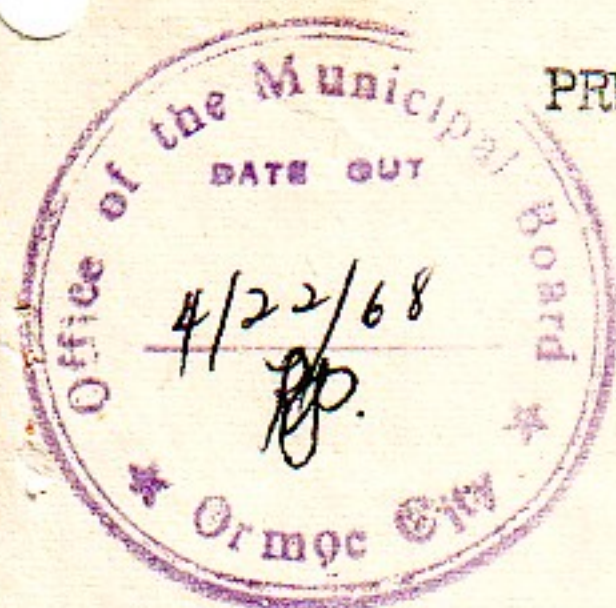

RESOLUTION NO. 125

A RESOLUTION REQUESTING THE HONORABLE CITY FISCAL TO FILE A
PETITION IN COURT FOR THE ISSUANCE OF TITLE IN FAVOR OF
THE CITY GOVERNMENT COVERING LOTS NOS. 8417-A AND 8418-A
SITUATED AT VALENCIA, ORMOC CITY



"WHEREAS, the Barrio Council of Barrio Valencia, Ormoc City, in its Resolution No. 1, current series, has requested the City Government to segregate portions of Lots Nos. 8417-A and 8418-A situated at said barrio containing an area of three thousand four hundred four (3,404) square meters, more or less, and to donate the same to the Roman Catholic Church, Diocese of Palo, Leyte, for the exclusive use of the barrio people for their spiritual needs;

"WHEREAS, records show that in a decision dated September 7, 1959, the Cadastral Court of Leyte has adjudicated the aforementioned lots in favor of the City Government but, nevertheless, up to the present these lots are not yet titled in the name of the City Government such that this august Body cannot as yet act on the resolution of the Barrio Council of Barrio Valencia asking for the donation of segregated portions of these lots to the Bishopric of Palo;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Kangleon;

"RESOLVED, to request the Honorable City Fiscal, Ormoc City, to file a petition in court for the issuance of title in favor of the City Government covering Lots No. 8417-A and 8418-A, to summon to his office, in this connection, for investigation of interested parties and to finally inform this august Body of the action taken by his office in this regard and the result of such action;

"RESOLVED, FURTHER, to hold in abeyance Resolution No. 1 dated March 3, 1968, of the Barrio Council of Barrio Valencia until such time when the Honorable City Fiscal shall have ultimately secured a title of adjudicated Lots Nos. 8417-A and 8418-A situated at Barrio Valencia in favor of the City Government;

"RESOLVED, FURTHERMORE, to adopt:

ORDINANCE NO. 35

AN ORDINANCE APPROPRIATING THE SUM OF TWO HUNDRED PESOS (P200.00) FOR INVESTIGATION, RELOCATION AND SURVEY OF LOTS NOS. 8417-A AND 8418-A SITUATED AT BARRIO VALENCIA, ORMOC CITY, IN ACCORDANCE WITH THE DECISION OF THE LEYTE CADASTRAL COURT DATED SEPTEMBER 7, 1959, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Two Hundred Pesos (P200.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury said sum to be made available as supplemental appropriation for investigation, relocation and survey of Lots Nos. 8417-A and 8418-A situated at Barrio Valencia, Ormoc City, in accordance with the decision of the Cadastral Court of Leyte dated September 7, 1959.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, April 17, 1968.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Honorable City Fiscal, the City Engineer, the City Auditor, the City Treasurer, and the Barrio Council of Barrio Valencia, all of Ormoc City;

"CARRIED UNANIMOUSLY."
