RESOLUTION NO. 128

"WHEREAS, Councilor Cesar Samson, Chairman of the Committee on Ways and Means, reported that copra dealers have made strong representations with his committee requesting the reduction of the storage tax for copra purchased, sold, stored, shipped or kept in the City of Ormoc to only twenty-two and one-half centavos (\$\mathbf{P}0.2250\$) instead of Thirty Centavos (\$\mathbf{P}0.30\$) as contemplated in Ordinance No. 18 dated February 14, 1968;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Navarro;

"RESOLVED, to adopt:

ORDINANCE NO. 38

AN ORDINANCE AMENDING, FURTHER, ORDINANCE NO. 7 AND ORDINANCE NO. 10. 24, BOTH SERIES OF 1964, AS AMENDED BY ORDINANCE NO. 18, SERIES OF 1968.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Title of the Ordinance. - The title of Ordinance No. 7, as amended by Ordinance No. 24, both series of 1964, as amended further by Ordinance No. 18, series of 1968, is hereby amended, further, to read as follows:

"AN ORDINANCE IMPOSING A STORAGE TAX OF TWO PESOS AND FIFTY CENTAVOS (\$2.50) FOR EVERY TON OF HEMP, MAGUEY, AND THE LIKE, AND TWENTY-TWO AND ONE-HALF CENTAVOS (\$0.2250) FOR EVERY SACK OF COPRA PURCHASED, SOLD, STORED, SHIPPED OR KEPT IN THE CITY OF ORMOC AND FOR OTHER PURPOSES."

SECTION 2. Section 1 of Ordinance No. 7, as amended by Ordinance No. 24, both series of 1964, as amended further by Ordinance No. 18, series of 1968, is hereby amended, further, to read as follows:

"SECTION 1. City tax. - Any person, partnership, firm, association or corporation duly licensed or engaged in buying and/or selling copra, hemp, maguey, and the like, who shall hold, keep or store the same at his place of business,

bodega or elsewhere within the jurisdiction of the City of Ormoc, shall pay to the City Treasurer a storage tax of Two Pesos and Fifty Centavos (\$\frac{1}{2}.50\$) for every ton of hemp, maguey, and the like, and Twenty-two and one-half centavos (\$\frac{1}{2}.2250\$) for every sack of copra purchased, sold, stored, shipped or kept by any person or entity subject to this Ordinance."

SECTION 3. Effectivity. - This Ordinance shall take effect immediately upon its approval.

ENACTED, April 17, 1968.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Honorable Municipal Councils of Palompon, Kananga, Albuera and Baybay, all of the Province of Leyte, with a request that they adopt the same ordinance; and, likewise, the Honorable City Judge, the City Fiscal, the City Treasurer, the City Auditor, and copra dealers, all of Ormoc City;
