RESOLUTION NO. 129

"WHEREAS, after careful review of Ordinance No. 18, series of 1965, entitled "An Ordinance Imposing a License Fee of Two Hundred Pesos (P200.00) upon any Fully-Licensed Engineer Employed in Industrial Establishments Using Steam Engines and/or Boilers and Providing Penalties for Violations Thereof" this august Body finds the same to partake of a class legislation as it applies only to engineers employed in industrial establishments and not to all engineers so that said ordinance in effect is also found to be a restraint on the engineering profession;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Navarro;

"RESOLVED, to adopt:

ORDINANCE NO. 39

AN ORDINANCE REPEALING ORDINANCE NO. 18, SERIES OF 1965

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Ordinance No. 18, series of 1965, entitled, "An Ordinance Imposing a License Fee of Two Hundred Pesos (P200.00) Upon Any Fully-Licensed Engineer Employed in Industrial Establishments Using Steam Engines and/or Boilers and Providing Penalties for Violations Thereof" is hereby repealed.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
