## RESOLUTION NO. 17

"WHEREAS, it is of common knowledge that the temporary city hall in Cogon Combado which houses the offices of the City Mayor, the Fifth Municipal Board, and the Police Department, was so heavily damaged by typhoon "Wilming" late last year that the City Government had ultimately abandoned its uses for the offices of the City Mayor and the Municipal Board and that the Honorable City Mayor is now holding office in the former residence of the City Engineer while the Municipal Board is now occupying the Parish Center Building;

"WHEREAS, the most venerable parish priest, Rt. Rev. Msgr. Francisco S. Santiago, has been so gracious enough to allow the Sixth Municipal Board to use the Parish Center Building from the very first day this Honorable Board assumed office and, as a matter of fact, the Inaugural Session was even held right here in this building;

"WHEREAS, the Parish Center Building has been continuously used up to the present by the Sixth Municipal Board availing itself of the light and water facilities, among other things, of this building;

WHEREAS, this august Body is aware of the inconvenience felt.

by the most respectable parish priest in that he can no longer use
this building at will out of respect so much so that it has become
urgent that we have to look for another building in the meantime
that the proposed temporary office and session hall of the Municipal Board is still undergoing construction at the Engineering compound; in order that the parish priest will be free again to use it;

"WHEREAS, even though we have just found a new place to house the Office of the Municipal Board, yet, it beehoves upon ourselves not just to vacate the parish center building without compensating the parish priest for our use of this building and, above all, expressing our heartfelt thanks and gratitude for such;

"WHEREAS, for his cooperation and benevolence, this august Body would like to offer to the parish priest a nominal rental of the Parish Center Building even in the meager sum of \$\mathbb{P}\$100.00 which may be just and equitable for the use of the building from the beginning up to the time the Sixth Municipal Board shall vacate the said building;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Tan;

"RESOLVED, to adopt:

ORDINANCE NO. 4 AN ORDINANCE APPROPRIATING THE SUM OF ONE HUNDRED PESOS (P100.00) TO BE MADE AVAILABLE AS SUPPLEMENTAL APPRO-PRIATION FOR NOMINAL RENTAL OF THE PARISH CENTER BUILDING USED BY THE SIXTH MUNICIPAL BOARD

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of One Hundred Pesos (\$100.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the city treasury to be made available as supplemental appropriation for nominal rental of the Parish Center Building used by the Sixth Municipal Board from January 1, 1968, up to the time the Board shall vacate the building.

SECTION 2. This Ordinance shall take effect immediately upon = its approval,

ENACTED, January 10, 1968.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Rt. Rev. Msgr. Francisco S. Santiago, Parish Priest, the City Treasurer and the City Auditor, all of Ormoc City;
