## RESOLUTION NO. 130

"WHEREAS, after a careful review and study of Ordinance No. 14, series of 1965, entitled 'An Ordinance Requiring an Annual Permit from the City Mayor for the Construction and/or Operation of Railroads or Railways Crossing Public Highways and Provincial, Municipal, Barrio, Vecinal and Feeder Roads, or the like, Within the Territorial Jurisdiction of Ormoc City, providing Penalties for Violations thereof and for other Purposes', this august Body finds the same to be a dead law aside from its being discriminatory considering that these railways have been existing since 1930 and that only one establishment is operating and maintaining the same for whom the said ordinance is unfairly adopted;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 40

AN ORDINANCE REPEALING ORDINANCE NO. 14, SERIES OF 1965

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Ordinance No. 14, series of 1965, entitled "An Ordinance Requiring an Annual Permit from the City Mayor for the Construction and/or Operation of Railroads or Railways Crossing Public Highways and Provincial, Municipal, Barrio, Vecinal and Feeder Roads, or the like, within the Territorial Jurisdiction of Ormoc City, Providing Penalties for Violations Thereof and for Other Purposes" is hereby repealed.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
