BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Four Hundred Sixty Pesos (\$460.00), or so much thereof as may be necessary, is hereby reverted from salary savings of the Fire Department and/or appropriated out of funds not otherwise appropriated in the City Treasury, said sum to be made available as supplemental appropriation for the repair of one fire engine pump by the Romeo's Shop.
