RESOLUTION NO. 134

"WHEREAS, the Chief of the Fire Department, this City, in a letter of even date has requested that an appropriation of P460.00 be made for the repair of the fire engine pump as quoted by the Romeo's Shop in its letter enclosed dated March 29, 1968;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Aviles and the Floor Leader;

"RESOLVED, to approve the request of the Chief of the Fire Department, Ormoc City, and do, as this Body hereby does, adopt:

ORDINANCE NO. 12

AN ORDINANCE REVERTING THE SUM OF P460.00 FROM SALARY SAVINGS OF THE FIRE DEPARTMENT AND/OR OUT OF UNAPPROPRIATED FUNDS FOR THE REPAIR OF ONE FIRE ENGINE PUMP BY ROMEO'S SHOP

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Four Hundred Sixty Pesos (P460.00), or so much thereof as may be necessary, is hereby reverted from salary savings of the Fire Department and/or appropriated out of funds not otherwise appropriated in the City Treasury said sum to be made available as supplemental appropriation for the repair of one fire engine pump by the Romeo's Shop.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
