RESOLUTION NO. 138

"WHEREAS, the Honorable Chairman of the Committee on Police, Fire, and Public Safety, Councilor Juanito T. Kangleon, has recommended approval of a voucher jointly submitted by Sgts. Marciano Apas and Marcelo Capuyan of the Ormoc City Police Department representing payment of per diems and allowances in connection with their official trip to Talisay, Silay, Negros Occidental, to effect the arrest of Ernesto and Racquel Aguirre per warrant of arrest issued by the City Judge and as authorized by the Chief of Police and the Honorable City Mayor in their respective memoranda, all amounting to P129.90;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilors Samson and Navarro;

"RESOLVED, to adopt:

ORDINANCE NO. 43

AN ORDINANCE REVERTING FROM SALARY SAVINGS OF THE ORMOC CITY POLICE DEPARTMENT AND/OR APPROPRIATING OUT OF UNAPPROPRIATED FUNDS THE SUM OF P129.90 TO COVER TRAVEL AND TRANSPORTATION OF SGTS. MARCIANO APAS AND MARCELO CAPUYAN, OCPD.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of One Hundred Twenty-Nine Pesos and Ninety Centavos (P129.90), or so much thereof as may be necessary, is hereby reverted from salary savings of the Police Department and/or appropriated out of funds not otherwise appropriated in the City Treasury to be made available as supplemental appropriation for travel and transportation in the Police Department in connection with the official trip of Sgts. Marciano Apas and Marcelo Capuyan to Talisay, Silay, Negros Occidental, to effect the arrest of Ernesto and Racquel Aguirre.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
