AN ORDINANCE APPROPRIATING TWO HUNDRED PESOS FOR MISCELLANEOUS EXPENSES OF THE YOUTH VOLUNTEER MOVEMENT FOR BETTER HEALTH

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two hundred pesos (\$\frac{9}{200.00}\$), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise
appropriated in the City Treasury to be made available as supplemental
appropriation for the City Health Department in the implementation of the
Youth Volunteer Movement for Better Health in the City of Ormoc in compliance with a directive of His Excellency, the President of the Philippines,
dated April 6, 1968, through Department Circular No. 58 dated April 16,
1968, of the Honorable Secretary of Health.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
