RESOLUTION NO. 149

"WHEREAS, the Barrio Council of Barrio Esperanza, Ormoc City, in an unnumbered resolution dated May 2, 1968, has urgently requested a school aid in the form of galvanized iron sheets and nails for roofing of the school building constructed by the barrio people themselves which size is 34 by 18 feet and which, as estimated by Councilor Jose C. Aviles, needs no less than fifty pieces of galvanized iron sheets and other roofing materials costing at least P300.00;

"NOW, THEREFORE, on motion of Councilor Aviles, seconded by the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 45

AN ORDINANCE APPROPRIATING P300.00 AS SCHOOL AID TO BARRIO ESPERANZA, ORMOC CITY, FOR THE PURCHASE OF ROOFING MATERIALS FOR A SCHOOLHOUSE

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three hundred pesos (P300.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury to be made available as school aid to Barrio Esperanza, Ormoc City, for the purchase of roofing materials for the barrio schoolhouse.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
