RESOLUTION NO. 156

"WHEREAS, the Barrio Council of Barrio Mas-in, Ormoc City, in Resolution No. 3 of April 7, 1968, has requested an appropriation for the construction of sixty (60) school desks to be equally allocated to the five teachers of the community school;

"WHEREAS, Honorable Jose C. Aviles, Councilor-in-Charge of Barrio Mas-in, has reported that after a conference with the barrio officials of Mas-in the latter have agreed to supply free labor by carpenters of the community provided that the City Government will grant a school aid for the purchase of the necessary materials for the construction of the 60 school desks which is estimated to cost four hundred pesos (P400.00);

"NOW, THEREFORE, on motion of Councilor Aviles, seconded by the Floor Leader;

"RESOLVED, to approve Resolution No. 3, current series, of the Barrio Council of Barrio Mas-in, Ormoc City, and do, as this Body hereby does, adopt:

ORDINANCE NO. 46

AN ORDINANCE APPROPRIATING P400.00 FOR THE PURCHASE OF NECESSARY MATERIALS FOR THE CONSTRUCTION OF SIXTY (60) SCHOOL DESKS AS SCHOOL AID TO BARRIO MAS-IN, ORMOC CITY

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of four hundred pesos (P400.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated to be made available as supplemental appropriation for school aid for the purchase of necessary materials for the construction of 60 school desks of the Mas-in Community School: Provided, That labor will be supplied free by carpenters of the barrio.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, May 22, 1968.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the City Treasurer, the City Auditor, and the Barrio Council of Barrio Mas-in, all of Ormoc City;
