




EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE SIXTH

RESOLUTION NO. 161

"WHEREAS, the Heirs of Catalino Maglasang, have made representations with this august Body through the Honorable Chairman of the Committee on Finance, Councilor Jose G. Navarro, for immediate appropriation for rentals of their building used as office and bodega of the local Presidential Arm on Community Development (PACD) which have not been paid since July 1, 1966, up to the present, at the new rate of one hundred pesos (P100.00) per month or one thousand two hundred pesos per annum;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by the Floor Leader and Councilor Kangleon;

"RESOLVED, to adopt:

ORDINANCE NO. 48

AN ORDINANCE APPROPRIATING P2,400.00 OUT OF THE CITY COUNTERPART FUND FOR PACD PROJECTS AS SUPPLEMENTAL APPROPRIATION FOR OUTSTANDING AND CURRENT OBLIGATIONS OF THE CITY GOVERNMENT FOR RENTALS OF THE BUILDING OF THE HEIRS OF THE LATE CATALINO MAGLASANG USED AS OFFICE AND BODEGA OF THE LOCAL PACD FOR THE PERIOD FROM JULY 1, 1966, TO JUNE 30, 1968, AT THE RATE OF P100.00 PER MONTH.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two thousand four hundred pesos (P2,400.00), or so much thereof as may be necessary, is hereby appropriated out of the city counterpart fund for PACD projects to be made available as supplemental appropriation to cover outstanding and current obligations of the City Government for rentals of the building of the Heirs of the Late Catalino Maglasang used as office and bodega of the local PACD for the period from July 1, 1966, to June 30, 1968, at the rate of P100.00 per month: Provided, that similar appropriation be made in subsequent general appropriations for the same purpose.

SECTION 2. This Ordinance shall take effect immediately upon its approval

ENACTED, May 22, 1968.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Heirs of the Late Catalino Maglasang, the local PACD, the City Treasurer and the City Auditor, all of Ormoc City;
