ORDINANCE NO. 49

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one hundred twenty pesos (\$120.00), or so much thereof as may be necessary, is hereby appropriated out of the City Counterpart Fund for PACE Projects to be made available for payment of electric light consumption of the local Presidential Arm on Community Development (PACD): Provided, that this same item shall be incorporated in subsequent general appropriations.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
