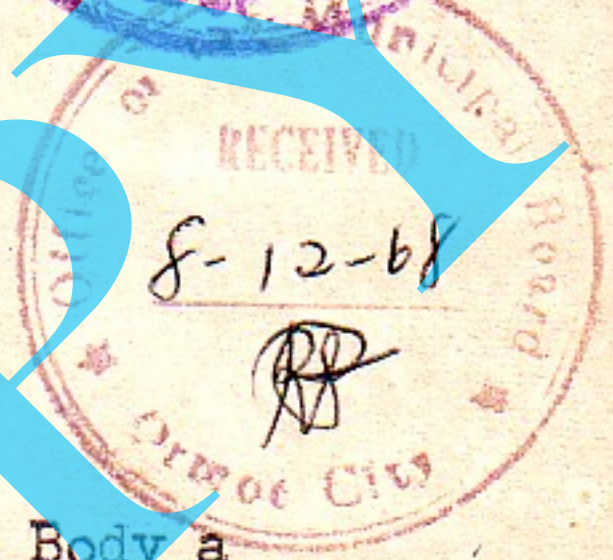

**RESOLUTION NO. 169**

"WHEREAS, the City Engineer has forwarded to this august Body a letter dated May 10, 1968, of Leyte Vice-Governor Alberto S. Veloso requesting our City's assistance and cooperation with the LEYTE EXPOSITION AND FAIR 1968 and the coming June 30 Tacloban City fiesta of which His Excellency, President Marcos, is the Hermano;

"WHEREAS, the City Engineer in his letter dated May 29, 1968, had requested this august Body to appropriate the sum of ₱690.00 representing our financial help in the construction cost of the Ormoc City booth as requested by Vice-Governor Veloso;

"NOW, THEREFORE, on motion of Councilor Aviles, seconded by Councilor Kangleon;

"RESOLVED, to adopt:

**ORDINANCE NO. 51**

AN ORDINANCE APPROPRIATING ₱690.00 FOR THE CONSTRUCTION OF  
THE ORMOC CITY BOOTH IN THE FORTHCOMING LEYTE EXPOSITION  
AND FAIR 1968 IN TACLOBAN CITY.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of six hundred ninety pesos (₱690.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the city treasury not otherwise appropriated to be made available for the construction of the Ormoc City booth in the forthcoming LEYTE EXPOSITION AND FAIR 1968 in Tacloban City.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, May 29, 1968.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Vice-Governor of Leyte, Tacloban City, the City Engineer, the City Treasurer and the City Auditor, all of Ormoc City;
