ORDINANCE NO. 51

AN ORDINANCE APPROPRIATING \$690.00 FOR THE CONSTRUCTION OF THE CRMOC CITY BOOTH IN THE FORTHCOMING LEYTE EXPOSI-TION AND FAIR 1968 IN TACLOBAN CITY.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of six hundred ninety pesos (\$690.00), or so - much thereof as may be necessary, is hereby appropriated out of funds existing in the city treasury not otherwise appropriated to be made available for the construction of the Ormoc City booth in the forthcoming LEYTE EXPOSITION AND FAIR 1968 in Tacloban City.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
