RESOLUTION NO. 171

"WHEREAS, there is a need to codify all legal ordinances of Ormoc City from the beginning of its existence up to now and then which would entail a starting expense of no less than one hundred fifty pesos (P150);

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 53

AN ORDINANCE APPROPRIATING P150.00 TO COVER EXPENSES IN THE
CODIFICATION OF ALL LEGAL ORDINANCES OF ORMOC CITY

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one hundred fifty pesos (P150.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the city treasury not otherwise appropriated to be made available for the expenses in connection with the codification of all legal ordinances of Ormoc City.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
