"WHEREAS, records will show that the Third Municipal Board of Ormoc City in Resolution No. 140 of August 2, 1956, had authorized then City Mayor Potenciano A. Larrazabal to effect and sign all necessary documents for and in behalf of the City Government relative to the exchange of city lots Nos. 8425, 8448-A and 8448-B located at Barrio Valencia with the portions of Lots Nos. 8457 and 8458 belonging to Mrs. Genevera Kavanaugh, Lot No. 8465 belonging to Mr. Fortunato Catingub, and Lot No. 8459-A belonging to Mrs. Emiliana Lorata, which portions are now utilized by the Valencia Elementary School site;

"WHEREAS, it has been found out that up to the present no actual subdivision had ever been made on the city lots above-mentioned in Barrio Valencia in spite of Resolution No. 140, series of 1956, of the Third Municipal Board of Ormoc City, although the parties concerned are already taking possessions of the city lots alloted to them in exchange of their respective lots;

"WHEREAS, it has become necessary to subdivide the aforementioned city lots in Barrio Valencia in order that they could be effectively exchanged with the corresponding private lots of the parties concerned together with their respective certificates of titles for their benefit in the possession of the lots;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilors Porcadilla and Mejia;

ESCLVED, to adopt:

ORDINANCE NO. 54

AN ORDINANCE APPROPRIATING THE SUM OF FIVE HUNDRED PESOS (\$500.00) TO BE MADE A VAILABLE FOR EXPENSES IN CON-NECTION WITH THE SUBDIVISION OF CITY LOTS NOS. 8425. 8448-A AND 8448-B LOCATED AT BARRIO VAIENCIA, ORMOC CITY, TO BE EXCHANGED WITH LOTS NOS. 8457 AND 8458 BELONGING TO MRS. GENEVERA KAVANAUGH, LOT NO. 8465 BELONGING TO MR. FORTUNATO CATINGUB, AND LOT NO. 8459-A BELONGING TO MRS. EMILIANA LORATA NOW UTILIZ-ED BY THE VALENCIA ELEMENTARY SCHOOL SITE.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Five Hundred Pesos (\$500.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury not otherwise appropriated to be made available for expenses in connection with the subdivision of City Lots Nos. 8425, 8448-A and 8448-B located at Barrio Valencia, Ormoc City, to be exchanged with Lots Nos. 8457 and 8458 belonging to Mrs. Genevera Kavanaugh, Lot No. 8465 belonging to Mr. Fortunato Catingub, and Lot No. 8459-A belonging to Mrs. Emiliana Lorata now utilized by the Valencia Elementary School Site.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, June 19, 1968.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to Mrs. Genevera Kavanaugh, Mr. Fortunato Catingub, Mrs. Emiliana Lorata, the City Treasurer, the City Auditor, the City Engineer, and the City Fiscal, all of Ormoc City;
