RESOLUTION NO. 194

"WHEREAS, through the incessant representations of the City Health Officer, the Mobile Chest Clinic has come to Ormoc City on a 31-working-day visit attending to fleuroscopic examinations of hundreds of residents free of charge, including medical prescriptions and medicines, although Ormoc City is not included in its itinerary so that it behooves upon the City Government to sustain its stay for the duration of its visit by way of meeting its financial obligation especially in the board and lodging of its four personnels;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilor Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 57

AN ORDINANCE APPROPRIATING P700.00 TO MEET FINANCIAL OBLIGATIONS OF THE FOUR PERSONNELS OF THE MOBILE CHEST CLINIC DURING ITS 31-WORKING-DAY VISIT IN THE CITY OF ORMOC

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Seven Hundred Pesos (P700.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury said sum to be made available for meeting financial obligations of the four personnels of the Mobile Chest Clinic of the Department of Health for the period of 31 working days.

SECTION 2. This ordinance shall take effect immediately upon its approval.
