ORDINANCE NO. 58

AN ORDINANCE REVERTING \$500.00 FROM SALARY SAVINGS IN THE POLICE DE-PARTMENT FOR BURIAL EXPENSES OF THE LATE PATROLMAN FELIX C. MARQUEZ.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five hundred pesos (#500.00), or so much thereof as may be necessary, is hereby reverted from salary savings accruing to the Police Department to be made available for appropriation for burial expenses of the late Patrolman Felix C. Marquez, in accordance with Section I, Rule XIII of Executive Order No. 113, dated December 30, 1967.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
