RESOLUTION NO. 210

"WHEREAS, the Acting Chief of Police in a letter dated August 8, 1968, has requested an appropriation of ₱500.00 for burial expenses of the late Patrolman Felix C. Marquez who died in line of duty on August 5, 1968, in Barrio Ipil, this City, which request falls within the provision of Section I, Rule XIII of Executive Order No. 113 dated December 30, 1967;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded jointly by all the other Councilors present;

"RESOLVED, to adopt:

ORDINANCE NO. 58

AN ORDINANCE REVERTING ₱500.00 FROM SALARY SAVINGS IN THE POLICE DEPARTMENT FOR BURIAL EXPENSES OF THE LATE PATROLMAN FELIX C. MARQUEZ.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five hundred pesos (₱500.00), or so much thereof as may be necessary, is hereby reverted from salary savings accruing to the Police Department to be made available for appropriation for burial expenses of the late Patrolman Felix C. Marquez, in accordance with Section I, Rule XIII of Executive Order No. 113, dated December 30, 1967.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, August 14, 1968.
