RESOLUTION NO. 217

"WHEREAS, the head of the smallpox vaccination team from the Regional Health Office, together with the City Health Officer, has appealed to this august Body for aid in the procurement of alcohol and cotton even just for the duration of their one-year stay in Ormoc City where they will cover not only the city proper but also the remotest barrio and the highest mountain in order to reach their target of the maximum smallpox immunity from eighty to eighty-five percent;

"WHEREAS, this august Body is more than willing to provide the vaccination team with the desired one-year supply of alcohol and cotton considering the tremendous returns it could give the people of Ormoc City by way of a long if not a lifetime immunization from the dreadful disease;

"NOW, THEREFORE, on motion of Councilor Navarro, jointly seconded by all the other Councilors present;

"RESOLVED, to adopt:

ORDINANCE NO. 59

AN ORDINANCE REVERTING THE SUM OF P300.00 FROM SALARY SAVINGS OF THE CITY HEALTH DEPARTMENT FOR THE PURCHASE OF ALCOHOL AND COTTON FOR USE OF THE SMALLPOX VACCINATION TEAM IN THE CITY OF ORMOC

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three hundred pesos (P300.00), or so much thereof as may be necessary, is hereby reverted from the salary savings of the City Health Department said sum to be made available for appropriation for the purchase of alcohol and cotton for one year's use of the smallpox vaccination team of the Regional Health Office now detailed in the City of Ormoc.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to Mr. Ernesto Prudencio, Head, Vaccination Team, the City Health officer, the City Treasurer and the City Auditor, all of Ormoc City; and the Regional Health Officer, Cebu City;
