RESOLUTION NO. 223

"WHEREAS, Councilor Albino P. Porcadilla, Chairman of the Committee on Laws and Ordinances, has reported that quite a number of motorists or drivers, especially of motorized tricycles, including rig drivers, have vigorously made representations with his committee requesting an amendment, furthermore, of Ordinance No. V, series of 1963, declaring Tuesday of every week as Special Market Day (tabu) in Ormoc City, so as to transfer its present site at a portion of Rizal Street to the City Tennis Court in order that the said portion of Rizal Street shall be open fully, not halfway, to vehicular traffic considering the hazards caused by these stalls of relief goods vendors every Tuesday for the duration of the Special Market Day;

"WHEREAS, Councilor Porcadilla has strongly recommended the amendment of the special market day ordinance for the benefit not only of the motorists or drivers and the stall owners affected but also the general public; and

"WHEREAS, this august Body is in accord with the Honorable Chairman of the Committee on Laws and Ordinances that the City Tennis Court is the safest and most ideal site for the special market day which is being held every Tuesday of the week and where stores or stalls do not constitute traffic hazards;

"NOW, THEREFORE, on motion of Councilor Porcadilla, jointly seconded by Councilor Kangleon and the Floor Leader;

"RESOLVED, to adopts


ORDINANCE NO. 60

AN ORDINANCE AMENDING FURTHERMORE SECTION 2 OF ORDINANCE NO.

V, AS AMENDED BY ORDINANCES NOS. VI AND VII, ALL SERIES
OF 1963, ENTITLED, "AN ORDINANCE DECLARING TUESDAY OF
EVERY WEEK AS SECIAL MARKET DAY (TABU) IN ORMOC CITY"
SO AS TO TRANSFER ITS PRESENT SITE AT A PORTION OF RIZAL
STREET TO THE CITY TENNIS COURT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Section 2 of Ordinance No. V, as amended by Ordinances Nos. VI and VII, all series of 1963, entitled, "An Ordinance Declaring Tuesday of Every Week as Special Market Day (Tabu) in Ormoc City," is hereby amended furthermore to read as follows:





"SECTION 2. For purposes of this Ordinance, the site of which the Special Market Day (Tabu) shall be held shall be the City Tennis Court."

SECTION 2. This Ordinance shall take effect immediately upon its approval.
