RESOLUTION NO. 228

"WHEREAS, several representations have been made before this august Body for some adjustments or amendments of the 1968-1969 Ormoc City Budget among which are the adjustment of the salary of one clerk in the Assessment Department from ₱1,800.00 to ₱2,040.00 per annum, the restoration of one Laborer in the Law Department at ₱1,800.00 per annum, the restoration of the cemetery keeper in the Health Department at ₱1,800.00 per annum, the amendment of the position and salary of the animal husbandry man at ₱2,400.00 to city veterinarian at ₱3,000.00 per annum, in the Agricultural Extension Service, and the item on collection and disposal of garbage and rubbish from ₱10,000.00 to ₱20,000.00 in the Garbage Collection and Disposal;

"WHEREAS, the Honorable Chairman of the Committee on Finance, Councilor Jose G. Navarro, manifested that all these adjustments or amendments can be readily effected by reversion of salary savings in the various departments and/or offices of the City Government;

"WHEREAS, this august Body finds the urgency of the aforementioned adjustments or amendments of the 1968-1969 Ormoc City Budget for the good of public service;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 61

AN ORDINANCE AMENDING ORDINANCE NO. 52, CURRENT SERIES,
OTHERWISE KNOWN AS THE 1968-1969 ORMOC CITY BUDGET

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Section 2 of Ordinance No. 52, current series, otherwise known as the 1968-1969 Ormoc City Budget, is hereby amended as follows:

a) On page 6, under (C-6) ASSESSMENT DEPARTMENT, the rate of compensation for the position of one (1) Clerk in Item No. 7 is adjusted from ₱1,800.00 to ₱2,040.00 per annum;

b) On page 7, under (C-10) LAW DEPARTMENT, a new item to be known as Item No. 7-A is to be inserted between Item No. 7 and Item No. 8 for the purpose of restoring the deleted position of one (1) Laborer with compensation at the rate of ₱1,800.00 per annum;

c) On page 10, under (C-17) HEALTH DEPARTMENT, a new item to be known as Item No. 19-A is to be inserted between Item No. 19 and Item No. 20 for the purpose of restoring the deleted position of one (1) Cemetery Keeper with compensation at the rate of ₱1,800.00 per annum;

d) On page 11, under (C-25-A) AGRICULTURAL EXTENSION SERVICE, Item No. 2 is amended from Animal Husbandry Man at ₱2,400.00 to City Veterinarian with compensation at the rate of ₱3,000.00 per annum; and

e) On page 12, under (C-27) GARBAGE COLLECTION AND DISPOSAL, the sum of ₱10,000.00 for the collection and disposal of garbage and rubbish to be undertaken by a private contractor or through public bidding or by Administration in Item No. 2 is adjusted to ₱20,000.00.

SECTION 2. All salary savings accruing to any and all departments and/or offices of the City Government are hereby reverted to be made available for appropriation to cover the adjustments provided for in Section 1 hereof: PROVIDED, That sufficient funds for this purpose shall be appropriated in subsequent general appropriation ordinances.


SECTION 3. This Ordinance shall take effect immediately upon its approval.


