RESOLUTION NO. 236

"WHEREAS, Acting City Fiscal Teofilo R. Redubla in a memorandum for the Municipal Board of Ormoc City has requested, among other things, an appropriation of ₱900.00 for this fiscal year to cover the difference between his salary now as Assistant Provincial Fiscal and that of a city attorney's considering that the Province of Leyte is already paying him ₱350.00 monthly;

"WHEREAS, Fiscal Redubla is really entitled to such claim as provided for by law;

"NOW, THEREFORE, on motion of Councilor Tan, jointly seconded by Councilors Aviles and Porcadilla and the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 63

AN ORDINANCE REVERTING ₱900.00 FROM OUT OF SALARY SAVINGS IN THE LAW DEPARTMENT FOR APPROPRIATION TO COVER SALARY DIFFERENCE OF ACTING CITY FISCAL TEOFILO R. REDUBLA, FOR THE FISCAL YEAR

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of ₱900.00, or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Law Department to be made available for appropriation to cover the salary difference of Acting City Fiscal Teofilo R. Redubla for the current fiscal year.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Secretary of Justice and the Honorable Solicitor General, both of Manila; the Honorable Provincial Fiscal, Tacloban City; and the Honorable Acting City Fiscal, the City Treasurer, and the City Auditor, all of Ormoc City;
