SECTION 1. The sum of \$\mathbb{P}900.00, or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Law Department to be made available for appropriation to cover the salary difference of Acting City Fiscal Teofilo R. Redubla for the current fiscal year.
