RESOLUTION NO. 241

"WHEREAS, the City Auditor in a communication dated September 18, 1968, has requested an additional appropriation for travel and transportation in the sum of P800.00 in view of the exhaustion of the same item for the current fiscal year and that he is going to Manila for a conference with the Auditor General and to follow up papers in the Civil Service Commission while his senior clerk is also attending the Civil Service Seminar in Tacloban City;

"WHEREAS, although the City Auditor recommends that the amount he requested could easily be reverted from salary savings in his department but, nevertheless, this august Body believes that P500.00 would be sufficient for travel and transportation of his office;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilor Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 64

AN ORDINANCE REVERTING P500.00 FROM OUT OF SALARY SAVINGS IN THE AUDITING DEPARTMENT FOR TRAVEL AND TRANSPORTATION PURPOSES OF SAID DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five hundred pesos (P500.00), or so much thereof as may be necessary, is hereby reverted out of salary savings in the Auditing Department to be made available as supplemental appropriation for travel and transportation of the said department.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
