ORDINANCE NO. 65

AN ORDINANCE AMENDING ITEM NO. 2 UNDER (C-36) MARKET AND SLAUGHTERHOUSE, PAGE 13, 1968-1969 ORMOC CITY BUDGET, BY DELETING THE TERM "MARKET COLLECTOR" SO THAT THE TERM "SPECIAL LABORER" WILL PREVAIL.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Section 2, particularly, Item No. 2 under (C-36) Market and Slaughterhouse, page 13 of Ordinance No. 52, current series, otherwise known as the 1968-1969 Ormoc City Budget, is hereby amended by deleting the term "Market Collector" so that the term "Special Laborer" will prevail.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
