ORDINANCE NO. 7

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 1, SERIES OF 1967, BY DELETING ITEM NO. 4 OF (C-3) AUDITING DEPARTMENT AND ITEM NO. 1 OF (C-28) PORTWORKS.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Abolition of positions. - Section 1 of Ordinance No. 1, series of 1967, is hereby amended by deleting Item No. 4 of (C-3) Auditing Department and Item No. 1 of (C-28) Portworks, abolishing in this connection the positions of Assistant Chief of Section and Wharfinger, respectively, for reasons of economy.

SECTION 2. The City Auditor and the City Treasurer shall, henceforth, respectively designate an employee each in their departments to handle the work appertaining to the positions herein abolished.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
