RESOLUTION NO. 32

"RESOLVED, to adopt:

ORDINANCE NO. 8

AN ORDINANCE CREATING THE POSITION OF LABORER ATTACHED TO THE OFFICE OF THE CITY TREASURER WITH COMPENSATION AT THE RATE OF ₱2,160.00 PER ANNUM

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The position of one (1) laborer is hereby created to be attached to the Office of the City Treasurer with compensation at the rate of ₱2,160.00 per annum: PROVIDED, HOWEVER, that funds for this purpose be appropriated out funds not otherwise appropriated and that this item be incorporated in subsequent general appropriation ordinance or city budget.

SECTION 2. This ordinance shall take effect immediately upon its approval.
