"RESOLVED, to adopt:

ORDINANCE NO. 1

AN ORDINANCE REVERTING THE SUM OF THREE HUNDRED FIFTY PESOS (P350.00) FROM OUT OF ITEM NO. 8 OF AIDS AND TRANSFER OF FUNDS, 1968-1969 ORMOC CITY BUDGET, TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE REPAIRS AND IMPROVEMENT OF THE OFFICE OF THE CITY FISCAL.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three hundred fifty pesos (P350.00), or so much thereof as may be necessary, is hereby reverted from out of Item No. 8 of Aids and Transfer of Funds, page 14, 1968-1969 Ormoc City Budget, said sum to be made available as supplemental appropriation for the repairs and improvement of the office of the City Fiscal.


SECTION 2. This Ordinance shall take effect immediately upon its approval.




