RESOLUTION NO. 25

"WHEREAS, with the ever-increasing volume of business in the fish section of the public market it has been found that the said section can no longer efficiently serve the public owing to its congestion all throughout the day so much so that many of the fish vendors are now plying their trade along the alleys and sidewalks of the market while not a few of them display their fish on the street for lack of spaces for them inside the fish section;

"WHEREAS, it has been suggested that to solve this perennial problem in the fish section it would be better to expand this portion towards the Capahi building and/or the Aviles building across the creek demolishing, in this connection, the public toilet and erecting a new one, better and more sanitary, near the Aviles building or elsewhere within that vicinity, elevating the office building of the Market Administrator thereby opening the ground floor to provide more space for the vendors towards the side of the Capahi building;

"WHEREAS, the Honorable Chairman of the Committee on Markets and Slaughterhouses, Councilor Cesar Samson, reported that the plan for this purpose is being prepared by the Office of the City Engineer and in the prosecution of this project Councilor Samson suggested that it would be wise and proper to advise Mr. Jose Suganob, Mr. Vicente Punay, Mrs. Felisa Omega and a couple of Moslem vendors now occupying the area affected by the expansion of the fish section to vacate their places within thirty days to give way to the projected construction;

"WHEREAS, Item No. 4 of Capital Outlays, page 14, 1968-1969 Ormoc City Budget, provides five thousand pesos (P5,000.00) for the construction of a public toilet which this august Body would like to amend so as to include also the expansion of the fish section of the public market;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Navarro;

"RESOLVED, to adopt:

ORDINANCE NO. 11

AN ORDINANCE AMENDING ITEM NO. 4 OF CAPITAL OUTLAYS, 1968-1969 ORMOC CITY BUDGET, SO AS TO INCLUDE ALSO THE EXPANSION OF THE FISH SECTION OF THE PUBLIC MARKET.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Item No. 4 of Capital Outlays, under Section 2, page 14, of Ordinance No. 52, series of 1968, otherwise known as the "1968-1969 Ormoc City Budget," providing five thousand pesos (P5,000.00) for the construction of a public toilet, is hereby amended so as to include also the expansion of the fish section of the public market.

SECTION 2. This Ordinance shall take effect immediately upon its approval.


ENACTED, February 5, 1969.



"CARRIED UNANIMOUSLY."


