RESOLUTION NO. 28

"WHEREAS, the Acting City Auditor in a letter dated February 6, 1969, has requested the reversion of ₱2,000.00 from out of salary savings in his department to be made available for travel and transportation of said department inasmuch as this item has already been exhausted for the current fiscal year;

"WHEREAS, after computation the Honorable Chairman on Finance, Councilor Jose G. Navarro, manifested that we have to appropriate only ₱669.35 inasmuch as these are the actual expenses incurred so that the Acting City Auditor is willing to divert the ₱500.00 from repair of equipment and ₱169.35 from the balance of the reversion from the purchase of firearms;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 12

AN ORDINANCE REVERTING THE SUMS OF ₱500.00 FROM OUT OF ITEM NO. 15 AND ₱169.35 FROM OUT OF ITEM NO. 13 OF (C-3) AUDITING DEPARTMENT TO TRAVEL AND TRANSPORTATION OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of six hundred sixty-nine pesos and thirty-five centavos (₱669.35), or so much thereof as may be necessary, is hereby reverted from out of items in the (C-3) Auditing Department, page 5, 1968-1969 Ormoc City Budget, in the manner provided hereunder, to be made available as supplemental appropriation for travel and transportation of the same department:

Item No. 13 (Purchase of Firearms) ₱169.35
Item No. 15 (Repair of Equipment) 500.00 ₱669.35

SECTION 2. This Ordinance shall take effect immediately upon its approval.
