RESOLUTION NO. 34

"WHEREAS, this august Body is in receipt of a communication
from the City Engineer which is quoted hereunder, verbatim, to wit:

'S i r s :

'In connection with your Resolution No. 278 (Ordinance No. 78) s. 1968, we are submitting herewith a detailed cost estimate of one standard-size room of the proposed City high school building, semi-permanent, this City. The project calls for an appropriation of ₱3,000 to meet the cost of materials, labor, supervision, and contingencies in the construction of one room complete with posts, girds, roof framing and roofing only, without walls or partitions. The estimate reflects the prevailing cost of materials and labor in the locality.

'Based on this unit cost estimate, the ₱12,849.28 outlay under the above-numbered Resolution-Ordinance is barely enough to construct a one-storey FOUR-room building, with the ₱849.28 unexpended balance to be used partly for the sidings, as far as the amount could cover.

'We respectfully request, therefore, that the Resolution-Ordinance above mentioned be revised or amended to suit the actual requirements of a one-storey, four-room, sprawling schoolbuilding; or, to include the necessary additional sum for the construction of a two-storey, six-room schoolhouse as called for in the above-numbered Resolution-Ordinance.

"WHEREAS, the Honorable Chairman of the Committee on Public Works, Councilor Jose C. Aviles, reported that his committee, together with the Committees on Education and Finance, have agreed to the construction only of a one-storey-four-room building for the Ormoc City High School instead of a two-storey-six-room building, as recommended by the City Engineer, with the appropriation of ₱12,849.28 under Ordinance No. 78, series of 1968;

"NOW, THEREFORE, on motion of Councilor Aviles, jointly seconded by Councilors Porcadilla and Navarro;

"RESOLVED, to authorize the City Engineer to proceed with the construction of a one-storey-four-room building of the Ormoc City High School and do, as this Body hereby does, adopt:

ORDINANCE NO. 13

AN ORDINANCE AMENDING ORDINANCE NO. 78, SERIES OF 1968, SO AS TO SUIT THE ACTUAL REQUIREMENTS OF A ONE-STOREY-FOUR-ROOM BUILDING FOR THE ORMOC CITY HIGH SCHOOL, SEMI-PERMANENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Amendment. - Section 1 of Ordinance No. 78, series of 1968, is hereby amended to read as follows:

"SECTION 1. The sum of twelve thousand eight hundred forty-nine pesos and twenty-eight centavos (₱12,849.28), or so much thereof as may be necessary, is hereby reverted from Item No. 26 (Construction of Home Economics Building) under (D-21) High School Fund, page 15, of the 1968-1969 Ormoc City Budget, to be made available as supplemental appropriation for the construction of a one-storey-four-room semi-permanent building of the Ormoc City High School."

SECTION 2. This Ordinance shall take effect immediately upon its approval.






