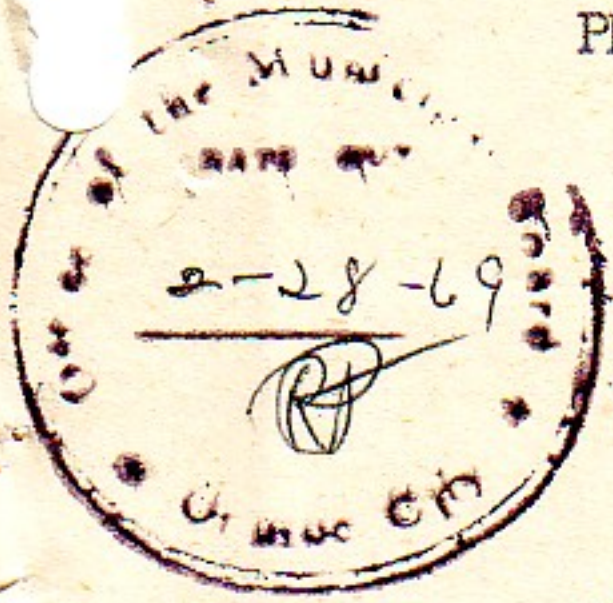

RESOLUTION NO. 36

"WHEREAS, the Honorable Chairman of the Committee on Finance, Councilor Jose G. Navarro, asserted that due to lack of personnel in the City Finance Department and due to lack of second grade eligibles in the City of Ormoc it would be to the interest of service that this Body create a position of laborer in the said department to be paid from out of salary savings of the same due to unfilled clerical positions;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilor Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 14

AN ORDINANCE CREATING THE POSITION OF ONE (1) LABORER IN THE CITY FINANCE DEPARTMENT WITH COMPENSATION AT THE RATE OF ₱2,040.00 PER ANNUM, PROVIDING FUNDS THEREFOR BY REVERSION, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The position of one (1) Laborer is hereby created in the City Finance Department with compensation at the rate of two thousand forty pesos (₱2,040.00) per annum to be paid from out of salary savings accruing to the said department due to unfilled positions thereof: Provided, However, that future funds for this purpose shall be provided in subsequent general appropriation ordinances.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, February 19, 1969.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Regional Director, Civil Service Commission, Eastern Visayas Regional Office, Cebu City; the City Treasurer and the City Auditor, both of Ormoc City;
