"RESOLVED, to adopt:

ORDINANCE NO. 15

AN ORDINANCE REVERTING THE SUM OF FIVE THOUSAND PESOS (P5,000.00) FROM OUT OF ITEM NO. 3 OF CAPITAL OUTLAYS, 1968-1969 ORMOC CITY BUDGET, FOR THE IMMEDIATE REPAIR OF THE OLD CITY HALL.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five thousand pesos (P5,000.00), or so much thereof as may be necessary, is hereby reverted from out of Item No. 3 (Ormoc City Hall) of Capital Outlays, page 14, 1968-1969 Ormoc City Budget, to be made available as supplemental appropriation for the immediate repair of the old City Hall.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
