ORDINANCE NO. 17

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND FOUR HUNDRED FIFTY PESOS (₱1,450.00) FROM ITEM NO. 2 OF (C-11) CITY COURT, 1968-1969 ORMOC CITY BUDGET, AS SUPPLEMENTAL APPROPRIATION FOR CONTINGENT EXPENSES OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand four hundred fifty pesos (₱1,450.00), or so much thereof as may be necessary is hereby re-verted from out of Item No. 2 of (C-11) City Court, page 7, 1968-1969 Ormoc City Budget, to be made available as supplemental appropriation for contingent expenses of the same department in the manner provided hereunder as follows:
