RESOLUTION NO. 45

"WHEREAS, our water supply is fast becoming insufficient due to increase in population and the subsequent increase in consumption adherent to modern trends of life, waste of water because of faulty faucets coupled with indiscriminate use by consumers, nas ture's influence on our water sources, and faulty mechanism from water deposits to our homes;

"WHEREAS, to forestall this worsening predicament there is a planned improvement of our water system by tapping new sources to supply the suburbs from Barrio Cogon Combado across the subdivision areas and as far as Barrio Naungan but this could only be possible - by loan application with the Development Bank of the Philippines;

"WHEREAS, the current charges in water rates are still of the 1949 vintage, maintained by the National Waterworks and Sewerage Authority, and of course were followed by the Ormoc Waterworks System;

"WHEREAS, there is an urgency to increase our water rates a little in order to augment our income to meet the amortization for the projected loan and, also, to increase our water pressure inasmuch as consumers will be constrained to conserve much water;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 18

AN ORDINANCE FIXING THE RATES OF PAYMENT IN CONNECTION WITH SERVICES OF THE ORMOC WATERWORKS SYSTEM.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. All rates of payment in connection with services of the Ormoc Waterworks System are hereby fixed in the manner provided hereunder as follows:

Provided, However, that any owner of land traversed by pipes of the System shall be allowed a minimum amount for free consumption of water not exceeding thirty (30) cubic meters per month and: Provided, Further, that the owner of the land where the water source comes from shall be charged only five pesos (\$\frac{1}{2}.00\$) per month for his water consumption.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
