RESOLUTION NO. 10

"WHEREAS, this august Body will remember having adopted Ordinance No. 68 (under Resolution No. 256), series of 1968, appropriating the sum of two hundred pesos (\$200.00) for the repair of the gutters in the public market area;

"WHEREAS, the Market Administrator in a letter dated October 30, 1968, had requested an appropriation for the purchase of lumber to cover the canals inside the public market which has become a hazard to the buying public;

"WHEREAS, the City Engineer in his 2nd indorsement of January 13, 1969, considering the urgency of the project for the protection of life and limb of market vendors, buyers, commuters and the general public, had recommended that the original outlay of two hundred peses (\$\frac{1}{200.00}\$) under Ordinance No. 68, series of 1968, be reverted to the purchase of materials for covers to the drainage canals of our public market and that this sum be boosted by an additional appropriation of three hundred thirty pesos (\$\frac{1}{2}30.00\$) for the same purpose, labor being supplied by market cleaners and/or laborers;

"NOW, THEREFORE, on motion of Councilor Navarro, jointly seconded by Councilors Aviles and Samson;

"RESOLVED, to adopt:

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED PESOS (\$\frac{1}{2}\)200.00)

FROM THE ITEM ON GUTTER REPAIRS UNDER ORDINANCE NO. 68,

SERIES OF 1968, AND THE SUM OF THREE HUNDRED THIRTY PE
SOS (\$\frac{1}{2}\)30.00) FROM OUT OF ITEM NO. 8 OF AIDS AND TRANS
FER OF FUNDS, 1968-1969 ORMOC CITY BUDGET, TO BE MADE

AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE PUR
CHASE OF MATERIALS FOR COVERS TO THE DRAINAGE CANALS

OF THE PUBLIC MARKET.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The following sums, or so much thereof as may be necessary, are reverted:

a) two hundred pesos (\$\frac{P}{200.00}\$) from the item on gutter repairs of the public market under Ordinance No. 68, series of 1968; and

b) three hundred thirty pesos (₱330.00) from out of Item No. 8 of Aids and Transfer of Funds, page 14, 1968-1969 Ormoc City Budget,

said sums to be made available as supplemental appropriation for the purchase of materials for covers to the drainage canals of the public market: Provided, That labor shall be supplied by the market cleaners and/or laborers.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, January 22, 1969.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the City Engineer, the Market Administrator, the City Treasurer and the City Auditor, all of Ormoc City;
