"WHEREAS, the City Assessor in a letter dated March 17, 1969, had requested the reversion of \$900.00 from out of salary savings and the unexpended balance for the purchase of the jeep to be made available for the overhauling, repair and purchase of spare parts of the office jeep inasmuch as the said vehicle is now out of order;

"RESOLVED, to approve the request of the City Assessor and do. as this Body hereby does, adopt:

ORDINANCE NO. 20

AN ORDINANCE REVERTING THE SUM OF NINE HUNDRED PESOS (\$900.00) FROM OUT OF SALARY SAVINGS AND THE UNEXPENDED BALANCE FOR THE PURCHASE OF JEEP IN THE ASSESSMENT DEPARTMENT TO BE MADE AVAILABLE AS SUP-PLEMENTAL APPROPRIATION FOR OVERHAULING, REPAIR AND PURCHASE OF SPARE PARTS FOR THE JEEP OF THE SAID DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of nine hundred pesos (\$900.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings and the unexpended balance for the purchase of the jeep in the Assessment Department, said sum to be made available as supplemental appropriation for overhauling, repair and purchase of spare parts of the jeep of the said department.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
