ORDINANCE NO. 21

AN ORDINANCE REVERTING THE SUM OF TWO THOUSAND SIX HUNDRED PESOS (\$2,600.00) FROM OUT OF SALARY SAVINGS AND AN UNEXPENDED ITEM IN THE ORMOC CITY WATERWORKS SYSTEM TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE PURCHASE OF FORTY (40) UNIT'S OF WATER METERS.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two thousand six hundred pesos (\$2,600.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings and the unexpended item on pipeline extension projects of the Ormoc Waterworks System, the said sum to be made available as supplemental appropriation for the purchase of forty (40) units of
