RESOLUTION NO. 57

"WHEREAS, the Waterworks Supervisor in a letter dated March 28, 1969, had requested the reversion of ₱772.00 from salary savings and ₱1,828.00 from the item on pipeline extension projects of his department, said amounts aggregating the sum of ₱2,600.00 to be made available for the purchase of 40 units of water meters;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by Councilor Kangleon;

"RESOLVED, to approve the request of the Waterworks Supervisor and do, as this Body hereby does, adopt:

ORDINANCE NO. 21

AN ORDINANCE REVERTING THE SUM OF TWO THOUSAND SIX HUNDRED PESOS (₱2,600.00) FROM OUT OF SALARY SAVINGS AND AN UNEXPENDED ITEM IN THE ORMOC CITY WATERWORKS SYSTEM TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE PURCHASE OF FORTY (40) UNITS OF WATER METERS.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two thousand six hundred pesos (₱2,600.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings and the unexpended item on pipeline extension projects of the Ormoc Waterworks System, the said sum to be made available as supplemental appropriation for the purchase of forty (40) units of water meters.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, April 30, 1969.
