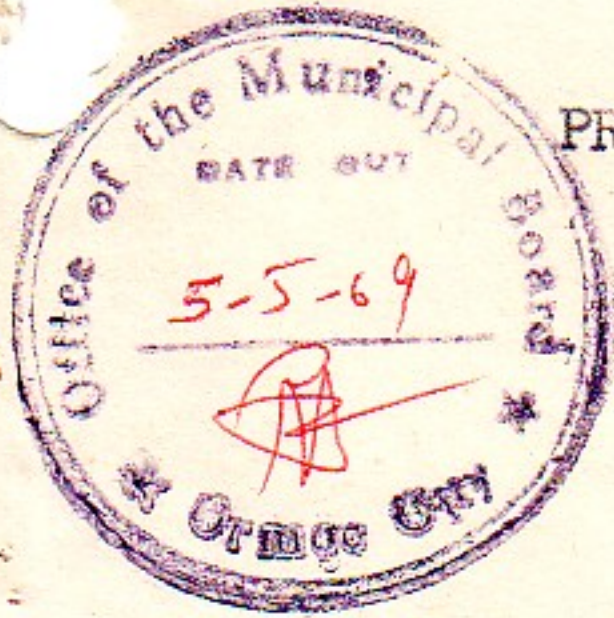

RESOLUTION NO. 58

"WHEREAS, the Deputy Chief of Police in a letter dated March 21, 1969, had informed this august Body that the item on the subsistence of prisoners had already been in the red since November, 1968, and, therefore, had requested an appropriation of eight thousand pesos (P8,000.00) to cover the overdraft and to maintain the same item up to the end of the current fiscal year;

"WHEREAS, the Deputy Chief of Police had also requested an appropriation of seven hundred pesos (P700.00) for the shifting of insular prisoners to the state penitentiary in Muntinlupa, Rizal, in order to solve the problem of congestion in the city jail following the absence of a judge of the Court of First Instance for quite a period of time thereby leaving some or most of the prisoners to wait for trial and final judgment even as they overcrowd the city jail to the danger of the health of these inmates now numbering eighty-three (83);

"WHEREAS, upon verification of the records, it has been found out that as of February 28, 1969, the amount of fifteen thousand nine hundred ninety-two pesos and thirty centavos (P15,992.30) had already been expended for the maintenance of prisoners so much so that with an appropriation for this item in the amount of only seven thousand pesos (P7,000.00) for the current fiscal year there has been an overdraft of eight thousand nine hundred ninety-two pesos and thirty centavos (P8,992.30) which account will be mounting up to the end of the fiscal year which is still four months away from February if nothing will be further appropriated to cover up and maintain the same item;

"WHEREAS, further verification reveals that as of today, April 30, 1969, the amount of one thousand sixty-two pesos (P1,062.00) had already been expended for travel and transportation of prisoners so that with an appropriation of two thousand pesos (P2,000.00) for this item there is still an unappropriated balance of nine hundred thirty-eight pesos (P938.00);

"WHEREAS, this august Body finds the urgency of appropriating supplementally for the further maintenance of the city prisoners up to the end of the fiscal year on June 30, 1969, and the shifting of insular prisoners to Muntinlupa, Rizal, in order to alleviate the condition of the city jail;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Porcadilla;

"RESOLVED, to consider the request of the Deputy Chief of Police and do, as this Body hereby does, adopt:



ORDINANCE NO. 22

AN ORDINANCE REVERTING THE SUM OF THIRTEEN THOUSAND PESOS (P13,000.00) FROM OUT OF SALARY SAVINGS IN THE POLICE DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR MAINTENANCE, TRAVEL AND TRANSPORTATION OF PRISONERS.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of thirteen thousand pesos (P13,000.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Police Department, said sum to be made available as supplemental appropriation in the manner provided hereunder as follows:

(a) For maintenance of prisoners .....	P 12,938.00
(b) For travel and transportation of prisoners (in addition to the un- expended balance of P938.00) .....	62.00
Total .....	P 13,000.00

SECTION 2. This Ordinance shall take effect immediately upon its approval

ENACTED, April 30, 1969:

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Deputy Chief of Police, the Deputy City Warden, the Caterer, the City Treasurer and the City Auditor, all of Ormoc City;

"CARRIED UNANIMOUSLY."
