RESOLUTION NO. 60

"WHEREAS, the Honorable Chairman of the Committee on Police, Fire and Public Safety, Councilor Juanito T. Kangleon, has reported that three members of the Ormoc City Police Department are now undergoing training in the Regional Police Academy of the Police Commission in Lahug, Cebu City, for whom an amount of sixty-five pesos (P65.00) each (or a total of P195.00) is needed for the necessary articles required in connection with their training which amount they could not further afford with their present rates of compensation;

"NOW, THEREFORE, on motion of Councilor Kangleon, jointly seconded by Councilors Porcadilla and Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 23

AN ORDINANCE REVERTING THE SUM OF ONE HUNDRED NINETY-FIVE PESOS (P195.00) FROM OUT OF SALARY SAVINGS IN THE POLICE DEPARTMENT TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION IN CONNECTION WITH THE TRAINING OF THREE POLICEMEN IN THE REGIONAL POLICE ACADEMY

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one hundred ninety-five pesos (P195.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Police Department, said sum to be made available as supplemental appropriation for necessary articles need in connection with the training of three members of the Ormoc City Police Department in the Regional Police Academy of the Police Commission in Lahug, Cebu City.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
