RESOLUTION NO. 61

"WHEREAS, the Honorable Chairman of the Committee on Finance, Councilor Jose G. Navarro, has underscored the necessity of updating our appropriation for Garbage Collection and Disposal owing to the present set up where one shift works in the evening and another during the day;

"NOW, THEREFORE, on motion of Councilor Navarro, jointly seconded by Councilor Porcadilla and the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 24

AN ORDINANCE REVERTING THE SUM OF TWELVE THOUSAND PESOS (P12,000) FROM OUT OF SALARY SAVINGS IN THE AGRICULTURAL EXTENSION SERVICE TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR GARBAGE COLLECTION AND DISPOSAL.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of twelve thousand pesos (P12,000.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Agricultural Extension Service, said sum to be made available as supplemental appropriation for Garbage Collection and Disposal.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
