RESOLUTION NO. 62

"WHEREAS, the City Election Registrar in a letter dated April 17, 1969, has requested an appropriation of one hundred fifty pesos (P150.00) for the repair and improvement of his office which roof is leaking causing some portions of the ceiling to fall leaving a wide opening where a very offensive odor emanating from decaying dead bats and their wastes always fill the room even as the main entrance to his office has no door shutter to fully secure their records and office equipment;

"NOW, THEREFORE, on motion of Councilor Navarro, jointly seconded by Councilors Kangleon and Samson;

"RESOLVED, to approve the request of the City Election Registrar and do, as this Body hereby does, adopt:

ORDINANCE NO. 25

AN ORDINANCE REVERTING THE SUM OF ONE HUNDRED FIFTY PESOS (P150.00) FROM OUT OF SALARY SAVINGS IN THE AGRICULTURAL EXTENSION SERVICE TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE REPAIR AND IMPROVEMENT OF THE OFFICE OF THE CITY ELECTION REGISTRAR.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one hundred fifty pesos (P150.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings of the Agricultural Extension Service, said sum to be made available as supplemental appropriation for the repair and improvement of the Office of the City Election Registrar.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
