RESOLUTION NO. 63

"WHEREAS, after verification of the records following the request of the Acting City Auditor for reversion of ₱400.00 from salary savings of his department to travel and transportation for Mr. Francisco O. Pepito's in attending the 11th National Conference on Public Personnel Administration in Pasig, Rizal, it has been found out that there is a balance available for reversion;

"NOW, THEREFORE, on motion of Councilor Navarro, seconded by the Floor Leader;

"RESOLVED, to consider the request of the Acting City Auditor and do, as this Body hereby does, adopt:

ORDINANCE NO. 26

AN ORDINANCE REVERTING THE SUM OF FOUR HUNDRED PESOS (₱400.00) FROM OUT OF SALARY SAVINGS OF THE AUDITING DEPARTMENT TO TRAVEL AND TRANSPORTATION FOR MR. FRANCISCO O. PEPITO OF THE SAME DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of four hundred pesos (₱400.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Auditing Department said sum to be made available as supplemental appropriation for the travel and transportation of Mr. Francisco O. Pepito, Senior Clerk, to Pasig, Rizal, in connection with the 11th National Conference on Public Personnel Administration.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
