

RESOLUTION NO. 66

"WHEREAS, Mrs. Corazon Paz-Aviles has made representations with this august Body for a grant of compensation equivalent to six months! pay of her husband, the late Councilor Francisco D. Aviles, who died while serving as such city official, invoking in this connection Republic Act No. 779, otherwise known as the Elective Public Officials Compensation Act;

"WHEREAS, records show that the Fifth Municipal Board in Resolution No. 68 dated August 11, 1967, had already granted Mrs. Aviles a compensation equivalent to only five months' pay of her deceased husband considering that Councilor Francisco D. Aviles, at the time of his death on August 6, 1967, had still five months to have served before the expiration of his second term in December of that year and from whose item the compensation was charged against in order that she could avail herself of the amount before the new set of members of the Municipal Board took over in January, 1968, by which time the item would already be credited to the new incumbent City Councilor;

"WHEREAS, in justice to Mrs. Corazon Paz-Aviles this august Body would like her to enjoy the full benefits derived from Republic Act No. 779 by way of paying her the balance of the grant of compensation equivalent to one month's pay of her husband in the amount of six hundred pesos (\$600.00);

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 28

AN ORDINANCE APPROPRIATING THE SUM OF SIX HUNDRED PESOS (\$600.00) TO BE MADE AVAILABLE FOR PAYMENT TO MRS. GORAZON PAZ-AVILES AS BALANCE OF THE GRANT OF COM-PENSATION EQUIVALENT TO ONE MONTH'S PAY OF HER HUS-BAND, THE LATE CITY COUNCILOR FRANCISCO D. AVILES, IN FULL IMPLEMENTATION OF REPUBLIC ACT NO. 779.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of six hundred pesos (\$600,00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the city treasury not otherwise appropriated, said sum

to be made available as supplemental appropriation for payment to Mrs. Corazon Paz-Aviles as balance of the grant of compensation equivalent to one month's pay of her husband, the late City Councilor Francisco D. Aviles, in full implementation of Republic Act No. 779, otherwise known as the Elective Public Officials Compensation Act.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, May 7, 1969.

"RESOLVED, FURTHER, to furnish a copy of this resolutionordinance each to Mrs. Corazon Paz-Aviles, the City Treasurer, and the City Auditor, all of Ormoc City;
