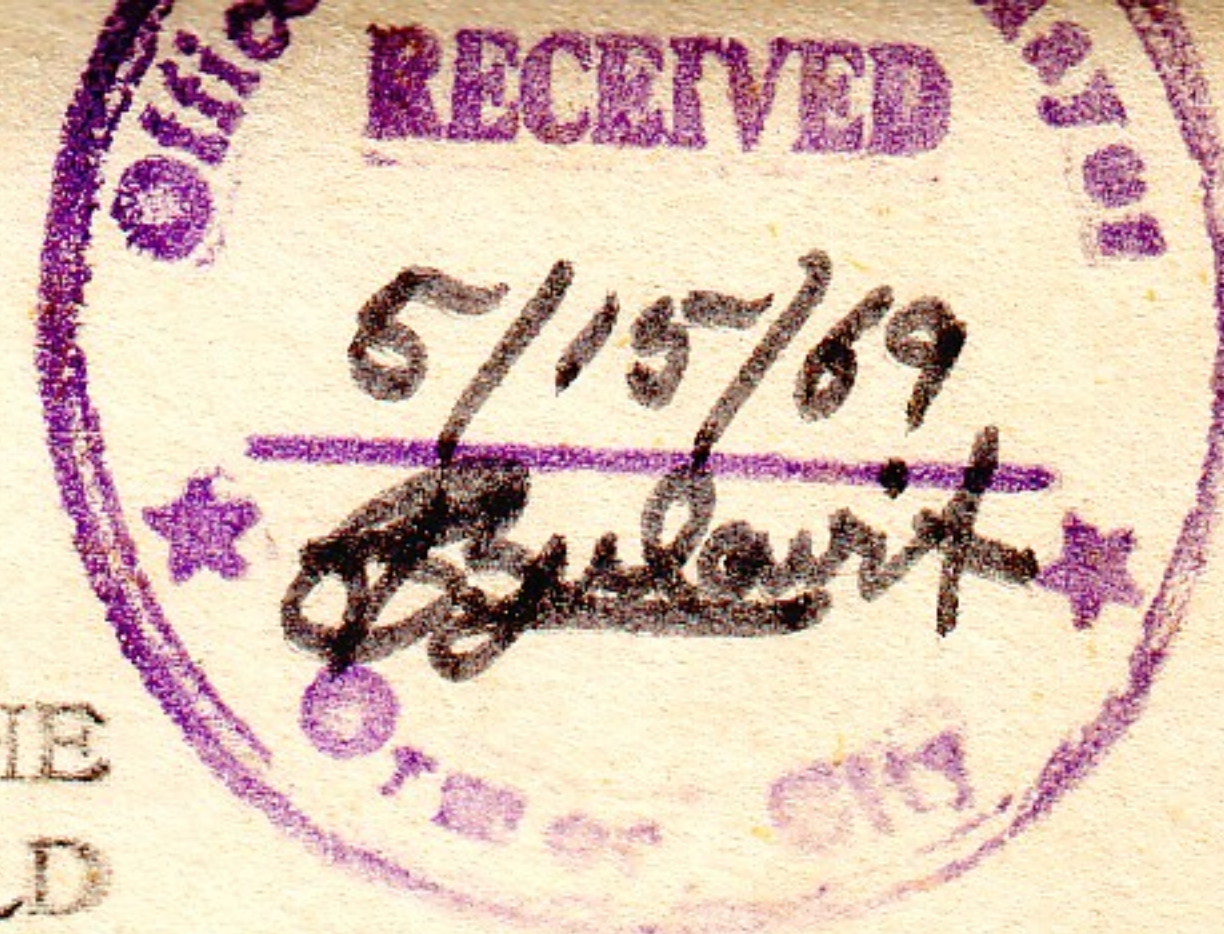

RESOLUTION NO. 67

"WHEREAS, the City Health Officer, in a communication of even date to the Honorable City Vice-Mayor and Presiding Officer of this Board, is earnestly requesting an aid to finish the most important reconstruction, repairs and improvement of the city health building which have been going on for the last several days and that he fears the same will abruptly stop due to lack of funds;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded jointly by Councilors Navarro and Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 29

AN ORDINANCE REVERTING THE SUM OF EIGHT HUNDRED PESOS (P800) FROM SALARY SAVINGS OF THE CITY HEALTH DEPARTMENT FOR THE RECONSTRUCTION, REPAIRS AND IMPROVEMENT OF ITS BUILDING.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of eight hundred pesos (P800.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings of the City Health Department, said sum to be made available as supplemental appropriation for the reconstruction, repairs and improvement of the city health building.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, May 7, 1969.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the City Health Officer, the City Treasurer, and the City Auditor, all of Ormoc City;
